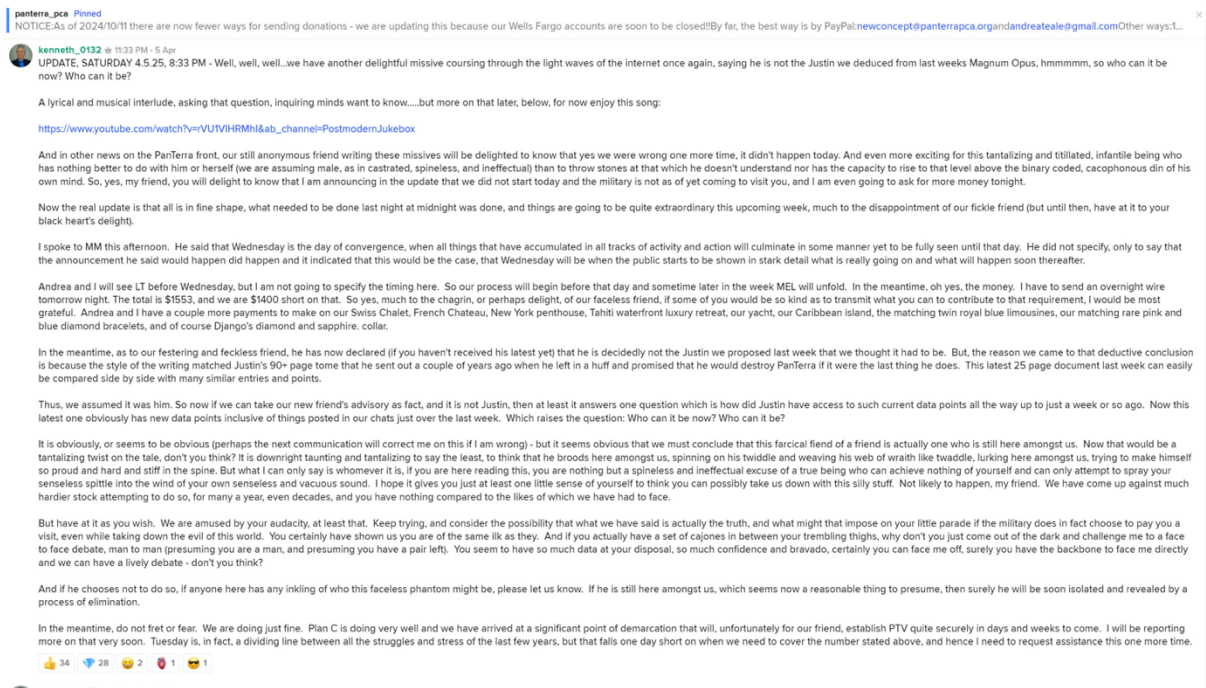

Justin Zaleski, who Andrea mentions above, is much more than a "very disgruntled ex-member" as Andrea describes him. He is a true sociopath and perhaps likely the term psychopath is applicable as well. We have never encountered someone so split in two as this individual. He came into our sphere soon before the November 2019 seminar that we had, and flew all the way in from Europe to attend that seminar. He then insisted he wanted to "really know us" and came to stay for a week. It all seemed pleasant enough. He told us a lot about his background and that he was now an expert in working with people and basically managed to wheedle himself in to be part of our new member interview team, in fact we ended up appointing him to lead that team and do many of the interviews. When I gave him some very gentle constructive pointers on one particular interview he did (after he had insisted to us that he wanted feedback to improve his technique), he turned into a howling monster and went into a rage. Within a couple of weeks we removed him entirely as there was no ability whatsoever to meet him with any logic or dialog as to what was going on. By that point he had also penetrated into other areas of our membership, especially the New Zealand group, and proceeded to wreck havoc there causing what could easily be seen as the root point of the unraveling of that entire country's membership that still reverberates with negative consequences to this day.

In all of our experience in dealing with many people who have split personalities, that come in with the bright side and leave with the dark siding rearing its ugly head, we have never seen something like this. There were at least 10-12 people who witnessed it, most from New Zealand because he got entangled in some issues there by using his position to pierce into the midst of those issues (and tried to assert some overarching control that was way out of line), and none could fathom how he went from my very simple and neutral input on his performance in a particular new member interview, to where it ended up within a matter of about a week or so. To demonstrate this schism in this being, have a look at the following. The first item is his original FPQ (Full Participation Questionnaire) that we did with members in 2020. You can see all the perfect answers that he wrote. The second item is his psychological profile that we had done for all the members who attended the November 2019 seminar. One member at that event linked us with a man in Las Vegas, where we went immediately after the seminar to meet. He has this process where one writes out certain words or phrases in block letters, draws a few simple designs, and writes in cursive some other liens. With that, this man (Jon West) can see exactly into the person's profile and determine his/her suitability for employment (that's mainly what he does it for, for companies in their HR department).

We had all the attendees at the seminar do the exercise/writing and took them to LV with us for the meeting with Jon. When we were sitting at dinner the night we met him, we handed him about a dozen or so of the members' writing/drawing papers, he could just look at each one and say "This one is a keeper, she is excellent in all the right ways" or "this one might be okay, but his flaws are such and such" and variations on all of that. When we handed him Justin's, he scoffed immediately and said "Forget about this one." We should have listened, but we were seduced by Justin's story and the bright persona he put forward first. Well, we learned that lesson later, didn't we?

You can see how the profile looks when you look at page two (but keep in mind it requires a lot more detail about how it works than what is on that page). We intended to hire Jon to do this for all members once we were funded, but he wanted to charge like \$1000 per profile, so we couldn't afford that of course (he did the batch from the seminar for free), and decided to wait until funding was in hand (which of course has been a long wait so far).

UPDATE, SUNDAY 3.30.25, 2:26 PM - If you have not read the morning's posts in Notices and Updates starting here --> [keybase:/chat/notices\\_updates#general/152346](#) - you should do so, so that this update makes sense.

Starting soon after making the posts that I did in Notices and Updates, I wrote a cover letter and sent that along with the nasty document to the MM text address. My letter basically said that this person (not a being) is threatening to publish this document in the public. I briefly stated that if we finally start this week it will negate the attempt to attack and destroy us, but if we didn't start this posed a serious problem for us, and the whole mission. MM called about 45 minutes after I sent it. He was very groggy as he was woken up to call me and was only briefly to the extent he could retain it. Of course, as is the case now, especially when he is first woken up, he was drugged and not very functional.

He told me that there was in fact a 72-hour cycle running since things were done on Friday and we would not start until Tuesday. He asked a few questions about the document and the main thing I said was that I wanted the military to get involved and go confront the author, that we knew who it was, and it was imperative that they did this. He said he had to wake up and get oriented, then he would make calls.

He just called back and said the military are investigating it and would report back to let me know what they are going to do. I said I have the name, location, and phone number and he said they will want that later. I got the impression they are taking it seriously and will deal with it as a real and serious threat. So our "friend" should expect some unexpected visitors in uniforms soon. In the interim since this morning, we have been discussing all of this and see some very interesting interconnects and twisted windings between various parties who have been problematic for us over the last five years, with an obvious common thread linking them together.

They are all in one of the main collectives that has been attacking and undermining us for years (and of course they aren't the only one, but are certainly the main one, all connected to an AI system known as YHWH. You know the story. As to the rest of the story, not going to go into it here, but suffice to say this is not a surprise and is part of the purging process of forcing all of these types out into the open to be exposed and defanged. Just part of our job description.

I also discussed with MM the timing of things relative to the recent Trump Truth announcement that April 2nd was "America Liberation Day" and he said he was told there would be some sort of announcement and this was most likely it, and no coincidence of the timing line up with our starting this week. He said it is firm that we will start, but we'll have to see how that works out. I have to send two more dailies and another number, for a total of \$2100 tonight, but I have that already in hand to send. However, that does deplete the treasury now, although we have enough coming in from Substack and Patreon to cover us for the week as long as nothing else shows up. Stand by for more news when it shows up. One never knows what will show up here in

Wimpy Ken seems to be a really slow learner and I see that he has once again been misbehaving and has gone off on a rant, making slanderous comments about my character, but let's clarify a few things first. I have never publicly discussed any content whatsoever about any person I have ever worked with, especially Wretched Andrea, because that's the ethical thing to do. Now one thing that Wimpy Ken has left out is that it was in fact Jolly, who had publicly disclosed, that I had worked with her, Wimpy Ken and Wretched Andrea and not me. Even though it would be delightful to expose the content from whenever I worked with Wretched Andrea, I still would never do this as it would be so inappropriate but I'm glad to see Wimpy Ken exposing his lack of integrity once again. Now, for the record, I did work with both Jolly and Wretched Andrea but she was incorrect in saying that I had worked with Wimpy Ken. He had planned to have a session with me, but it never happened. This may have been because he didn't want me to see, who the real Wimpy Ken was, or because of a time constraint, or perhaps he was busy with his favourite fetish of rescuing a damsel in distress? I'm also not sure if Wretched Andrea's emotional outburst, where she had emasculated Wimpy Ken in front of me, was a contributory factor or not but who really cares? Whenever I look back on it now, it was great to see Wimpy Ken being bitch slapped in front of me and Jolly and him taking it from Wretched Andrea like the bitch we all know he is.

I had also not violated the PTV NDA, at any time and I didn't share any video content of any kind. What I did do was to ask all members, who were already a part of Team Buddy, to go and view the 2 videos, which I

had uploaded there. This was something that all Team Buddy members had full access to and where those members regularly reviewed the applicant's interviews. Also, before I started doing all of the interviews, it was asked that at least 2 other members review an applicant's interview and provide their input. I did share a small amount of Mona's membership application, because it was so relevant, as to how the events unfolded and how Wimpy Ken also refused to discuss the matter, but I didn't include her in the mailing list. As many of you may already be aware, Wimpy Ken regularly uses his tried and tested "*activation is imminent*" excuse, as his get out of jail free card, to avoid any unpleasant situations he doesn't want to deal with. It appears to work very well, no matter how over used it has become and as we all know it has now become his signature tune and favourite repetitive mantra.

Wimpy Ken has said that I was the one who couldn't accept any feedback but what he has chosen to leave out, was the very important entire sequence of events that happened immediately beforehand. Doing this leaves out the uncomfortable part that Wimpy Ken doesn't want the members to know about and which he seems to be unable to address or process. Now I can't be certain what it was specifically that had triggered Wimpy Ken into having such an extreme reaction to the feedback I had provided, because Wimpy Ken refuses to openly debate the matter and he also refuses to declare why he won't debate the matter, other than his "*activation is imminent*" excuse but this is what I believe had happened.

Wimpy Ken, in a frenzied state of sleazy desperation, had guaranteed his latest fetish named Mona, membership to PTV through the "*Damsel in Distress*" fast tracking system and didn't notify me about it. Even though she's a nice lady, she had experienced a lot of trauma. To put someone through an interview process that could trigger someone, which was what happened, as I had said previously was "*grossly irresponsible*" for Wimpy Ken to do. She had provided virtually no paperwork or essay and all I was given was a few scribbled lines.

That's right, Wimpy Ken's behaviour and lack of awareness, in regards to his latest infatuation at that time and how he dealt with it was grossly irresponsible and Wimpy Ken seems to have had a strong reaction to this feedback and has since then, has found it difficult to process. Rather than accepting this feedback, which was intended to help him understand a recurring pattern and then question his own violations and errors from using the *Damsel in Distress* fast tracking system and learn from it. He instead had an emotional outburst and as narcissists always do, he attacked the person exposing his inappropriate behaviour, rather than evaluating the feedback. It seems that Wimpy Ken is experiencing difficulty in learning from this?

Perhaps if he just does a little bit more of the elusive inner work he talks so much about, he might figure it out, or he could keep doing the same thing over and over again, which is usually listening to Wretched Andrea talking out of her arse. I'm not sure what might be the right catalyst to cause Wimpy Ken to have a deep shift in consciousness and transcend the need for his addiction to the *Damsels in Distress* and hopefully therefore rendering it obsolete? Let's be optimistic and see how it all unfolds? I wonder how much "*inner work*" he's done in regards to my feedback about his behaviour?

Whenever you want to deeply understand someone and get to the core of their beliefs, or model of the world, working through that, as I did with Mona in her interview, can cause someone to release deeply suppressed emotions. In my direct experience, whenever people get triggered by these emotions, they can end up falling onto the floor and having seizures, or they can faint or temporarily lose consciousness. So once again for the record, I'm am saying that Wimpy Ken's behaviour was grossly irresponsible but rather than accepting that he has "*had a very low success rate with people who have been fast tracked*", as Jolly has pointed out, he has chosen to attempt to shoot the messenger. Now this strategy hasn't worked very well for him to date, but as you can understand, desperate people can end up doing desperate things. I'm once again providing a copy of Jolly's text to me for ease of referral.

I think that you are aware that we have had a very low success rate with people who have been fast tracked. Many of them were what I call super fast tracked, when they did not even have to send an essay before I allowed them into the website. These were all on direction from Ken. A few of the early ones were on direction from Andrea having read very well written essays. She then said she would not do that anymore, and did not do it after she said she would not do it. Ken, on the other hand, does tend to override the process when someone makes the direct connection with him, and he thinks there is something particularly special about them, and then I do ask directed, even when I have qualms about doing that!

So according to Jolly's own definition, Mona was Super-Fast Tracked and we must also acknowledge Jolly's magnificent understanding about how Wimpy Ken actually behaves and for her sharing her direct experience about how that usually works out.

Now we must give credit where credit is due and I know some of you may find this incomprehensible but Wretched Andrea had actually realised her errors within the fast-tracking system and stopped doing it, so well-done Wretched Andrea. On the other hand, Wimpy Ken seems to be a slow learner in this department and seems to have great difficulty in

learning from his repetitive mistakes but hopefully he'll figure it out soon?

Now, after I had written my summary about Mona's interview, I posted it into the Team Buddy group. I had raised concerns with Jolly immediately after the interview about Mona's Suitability and Wimpy Ken's wisdom about her becoming a member. I also believe Wretched Andrea was aware of our communication and this is where I think the problem initially developed.

Wretched Andrea in her state of desperation and delusion, with her unshakable belief that Wimpy Ken is the Messiah, got triggered and contacted Wimpy Ken in a state of distress and the emasculated Wimpy Ken, being Wretched Andrea's bitch, felt compelled to do what he was told, probably to avoid another one of those bitch slappings.

I'm posting my very brief summary of Mona once again for ease of accessibility...

*"Mona Hofmann was very triggered by me during the interview. She really struggles to actually answer any question and consistently goes off on elaborate meaningless tangents. I think this woman is still processing very deep levels of trauma and she finds it very hard to focus. I think her presence in PTV would be highly disruptive, especially at the crucial moment in time. She has so much projection going on and this is the first person ever that I've said that I don't think she should become a member. Her life is in chaos and I think she would need to do some deep inner work."*

We must ask the question. What is it that's going on in Wimpy Ken's life, that would compel him to want to be so involved, with someone that was obviously so unstable? Perhaps in his state of chaotic desperation, he had thought that he found the perfect vibrational match and couldn't control himself?

Initially, I was actually really surprised at Wimpy Ken's knee jerk reaction to my feedback but it all makes complete sense now. I had never realised until after the event, that Wimpy Ken, who appears to share the same delusion as Wretched Andrea and fully embodies his Messiah Complex, was so concerned with his own image. Just take a look at it from this perspective? Wimpy Ken being possessed with something other than common sense, has an overwhelming urge to rescue a *Damsel in Distress*, an urge that he can't control and brings his latest *Damsel in Distress* victim into PTV and bypasses all of the already well-established entry protocols that everyone else I've ever interviewed, had to go



through. This is another fine example of Wretched Andrea's bitch not following his own rules. Can you see the recurring pattern?

Now I had written about my observations to Jolly and also to Wretched Andrea. I then posted my video and interview summary into the Team Buddy group. Now after that, I was abruptly told that I had to stop doing interviews in a message from Jolly, until Wimpy Ken, had spoken to me. I believe this happened because that swamp creature better known as Wretched Andrea actually got triggered because someone actually called Wimpy Ken out on the absolute stupidity of his decision and as we all know, in Wretched Andrea's model of the world, anyone who doesn't believe Wimpy Ken is the Messiah, is a direct threat to the PTV cult. Now I was told by Jolly, that Wimpy Ken was going to message me within the hour but in the end, it took him over 3 days to do so. Why did Wimpy Ken not do what he said he was going to do?

The other thing to consider was that Wimpy Ken was so incredibly busy at that time, so he wouldn't have had the time to review the interview I had just done. So, the question is, who was it that give their overview or opinion on my interview? The only people who had access to Wimpy Ken at that time were Wretched Andrea and Jolly.

Another interesting observation was that he wrote incorrect things about me, which he posted within the PTV chats in public but then messaged me in private wanting to discuss the matter. Now that definitely wasn't going to work for me, so I told him that if he made a claim in public, that he was going to have to deal with that claim in the public. I think this is another example of his blatant double standards?

Did it take him 3 days to work out a strategy for his irrational behaviour and how to spin it, or was he just busy providing a lot of attention to detail, with his latest *Damsel in Distress*? One thing I'm absolutely certain of is Wimpy Ken doesn't like these questions. Where was his responsible communication? There wasn't any. Where's Ken's personal congruency? All I can see is a lack of it. Where's his authenticity? He doesn't have any. Is what we are seeing from Wimpy Ken the real Wimpy Ken, after his mask has slipped because he's being put under the spotlight? Now, not long after Wimpy Ken removed me from PTV because he couldn't deal with the accurate feedback, he attempted to reframe the situation, saying I couldn't deal with his feedback. However, his very important *Damsel in Distress*, who I said that "*I don't think she should become a member*", ended up departing from PTV almost as quickly as she arrived. Poor little Wimpy Ken made all of that effort and in the end, all he got was a lot of public humiliation and he ended up

looking like a limp dick and once again it exposed his personal incongruency.

So, what that really says is that my analysis of Mona was absolutely correct and to the point but will Wimpy Ken ever admit he was wrong and that he had seriously fucked up? Not a chance, the master of projection and the purveyor of the fake inner work couldn't handle that reality. Shall we await a public apology? I don't think it's coming? The harsh reality is that Mona was not right for PTV and even with the highest level of Wimpy Ken's intervention and infatuation, including the one-on-one VIP very special support package from Wimpy Ken, who was so determined to prove me wrong and show that he was right, finally has to swallow the harsh reality that he had fucked up. In reality, he fucked up really badly and his beloved latest fetish was gone, just like a puff of smoke. I also wonder how Wretched Andrea deals with Wimpy Ken's *damsels in distress* addiction?

These are just 3 questions from the New Member Questionnaire but it seems that these don't apply to Wimpy Ken? It seems like there are 2 sets of laws or rules within PTV. One set of laws for Wimpy Ken and Wretched Andrea and another set of laws for the members, which can change on a whim. This may be related to, or may be influenced by, Wretched Andrea's highly unstable, yet predictable emotional state.

Do you describe yourself as reliable? If you say you will do something, do you generally follow through?

Are you conscious of time in this reality – are you punctual, or always running late?

Are you a Being of your word in a team environment? – For example, if you say you will do something, will you always get it done?

As you can clearly see, Wimpy Ken is above this trivia that other members are subjected to and if you dare question the rules of Wimpy Ken's system, then you are the problem. Everyone is accountable to Wimpy Ken but Wimpy Ken is accountable to no one. Anyone questioning the integrity of Wimpy Ken or Wretched Andrea will be severely dealt with.

Some of you may have had such an experience?

Now if anyone questions Wimpy Ken's motives for his irrational behaviour, there will be consequences. Wimpy Ken the text book narcissist using his superior authority and overwhelming intellect, will

probably diagnose you as being seriously deficient in inner work and as a punishment you may be forced to watch some inner work videos starring Wretched Andrea or Wimpy Ken, where they will whine about all of their misery and attempt to convince their victims, that their self-inflicted misery is all your fault. Beware of the fake inner work gurus and the noise they spew out of their mouths and look at the actual results they have achieved, not what they say they've achieved.

One of the basic presuppositions of NLP is that *"If the messenger is incongruent, the message will not get through"*.



Once again, this is what I had sent to Jolly after I did the interview. I don't think Wimpy Ken liked it? I think Wimpy Ken got triggered because Wretched Andrea got triggered? It took him 3 days to sort out his dilemma. I think he realised, that if the shit were to hit the fan with Mona and Wimpy Ken's error in judgement, was widely known throughout PTV, then his self-image, which seems to be of such importance to him, had the potential of becoming even more tarnished and Wimpy Ken would have been thoroughly exposed. As you can see, I had already acknowledged that it was Wimpy Ken's decision. I was only giving my professional opinion and I had no attachment to the outcome.

Now, if Wimpy Ken wasn’t so insecure and didn’t have such an inflated ego, he could have easily accepted my feedback or rejected it and moved on. I suppose Wimpy Ken is following the good old tried and tested formula, of attacking or discrediting someone, who could shine a spotlight, on his questionable behaviour, rather than actually addressing the specific issues that were raised. For a man who talks a lot about peace, he sure does a lot of vicious attacking and has a war like mindset, wouldn’t you agree? I suppose it’s the smokescreen he tries to use to distract from the focus on Wimpy Ken, especially if things were to unfold in a manner not to his liking. He really does seem to get some perverse kick out of removing members with the most sadistic methods he can use. I suppose whoever you hang around with is who you become?

We added justin\_1470 to the New Member On-Shoring Team sub-team, the NMOST-Inner-Guidance Team because Justin is very experienced in working with people with their stuff and to guide and support them, and he is very good at reading where people are by asking them very pertinent questions and by being very neutral, allowing people to be who they really are. We had Terry write an

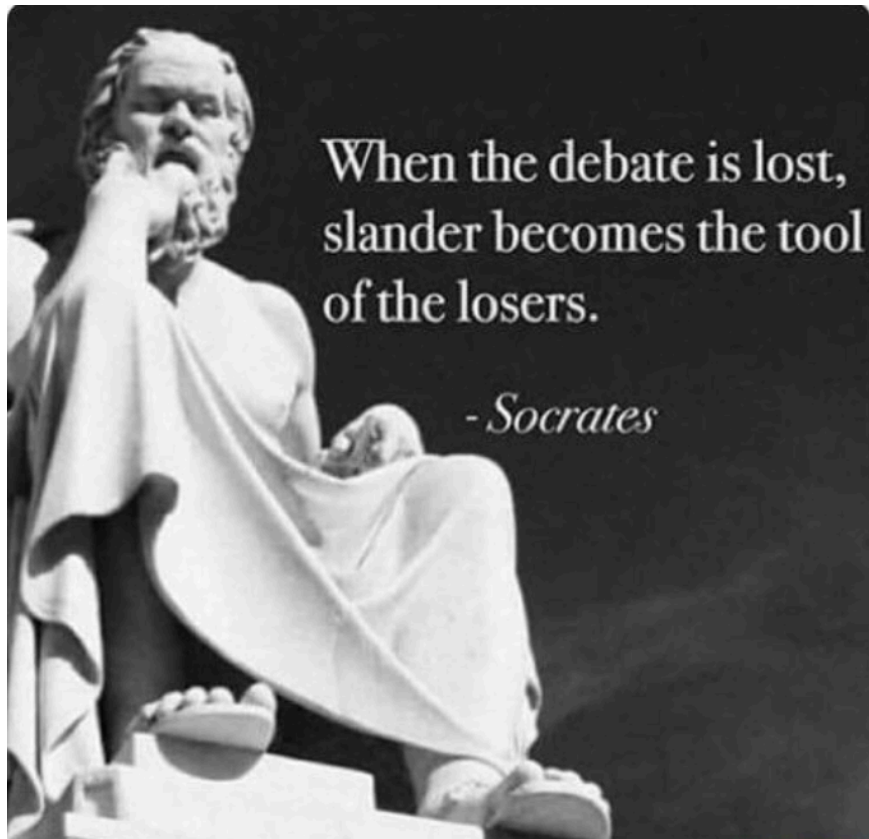

My right to Dispute Resolution is as follows...

## G. DISPUTE RESOLUTION AND COMPLIANCE OF LAW

1. In the event of a need to settle any dispute of a substantial nature, any Party may petition the other Party to an arbitration hearing pursuant to rules of arbitration under the International Chamber of Commerce and the American Arbitration Association. Any such board of arbitration shall be chosen from a pool of other Members of the PanTerra D'Oro (PanTerraVida) Private Contract Association ("PCA") with the intent of achieving a satisfactory resolution of the issue(s). Each Party shall choose one Member for the arbitration board and these two shall in turn choose a mutually acceptable third Member. If such initial board selected from PCA Members does not find a satisfactory resolution then the parties shall present their dispute to the PanTerraVida Court of the Ekklesia and be bound by the decisions thereof.
2. If arbitration is not sufficient to reach a settlement of a matter, the parties agree to enter into a formal process provided for in the jurisdiction and venue of the PanTerraVida Court of the Ekklesia. This specifically refers to the aggrieved party establishing a Court of Record pursuant to the tenets of Common Law, and inclusive of the Maxims of Equity and following the rules of the Court therein.

I also spoke with my friend Shelia once again, who has the most amazing psychic abilities and was able to accurately track Wimpy Ken, Wretched Andrea and MM. The issue within this system was whenever I refused to write something down in cursive writing. and I never will. I'm also in control of my destiny and I don't do things I don't want to do.

I warned Wimpy Ken not to misbehave but some people are slow learners. Then he posts all of this crap again saying I'm a psychopath and then writes another load of crap and posts it in a document. The reason I think Wimpy Ken called me a psychopath was because I just don't get triggered by him. In reality, I find his emotional outbursts highly entertaining. UPDATE, SUNDAY 3.30.25, 2:26 PM - If you have not read the morning's posts in Notices and Updates starting here --> [keybase://chat/notices\\_updates#general/152346](#) - you should do so, so that this update makes sense.

Starting soon after making the posts that I did in Notices and Updates, I wrote a cover letter and sent that along with the nasty document to the MM text address. My letter basically said that this person (not a being) is threatening to publish this document in the public. I briefly stated that if we finally start this week it will negate the attempt to attack and destroy us, but if we didn't start this posed a serious problem for us, and the whole mission. MM called about 45 minutes after I sent it. He was very groggy as he was woken up to call me and was only briefly to the extent he could retain it. He just called back and said the military are investigating it and would report back to let me know what they are going to do. So our "friend" should expect some unexpected visitors in uniforms soon. In the interim since this morning, we have been discussing all of this and see some very interesting interconnects and twisted windings between various parties who have been problematic for us over the last five years, with an obvious common thread linking them together.

They are all in one of the main collectives that has been attacking and undermining us for years (and of course they aren't the only one, but are certainly the main one, all connected to an AI system known as YHWH. You know the story. One final note, with the additional details and private data about us that was included in the document that went all the way up to end of February, it is obvious that the author is collaborating with other members. Most likely they are es-members, but it is not out of the question that they are still current members. I wish to make it very clear that we will not only stand firm in our position to remain grounded and secure against this latest of attempts to undermine us, but we will most certainly be proactive in finding out who has participated in this situation. If you didn't understand or realize it now, we do in fact have the full backing and utility of the entire worldwide military alliance to back us and protect us, even though it might appear differently due to the seemingly limited contact we have with all of that. We have had many instances that have not been reported over the years that required me to report these kinds of incidents, and they take it very serious and respond right away. In the peace time, in this eternal moment of Now, today we have a bit of an update. I did in fact speak with MM earlier. He has been under serious sedation since I spoke to him last Thursday, the last call we had until now. We still have a horse in the race and all remains on track (the horse race track, that is), and nothing has changed in what we expect, other than the timing.

Since he has been under sedation and pretty much sleeping around the clock except to be woken up occasionally to attend to meals and other bodily requirements, he is out of the loop on almost all fronts and present time reporting. He called to tell me that we will start next Monday and when I asked about that, he said he didn't know why. Then I explained about the DJT Executive Order pertaining to securing the border, the 90-day period for the report on the Insurrection Act potential activation, the militarizing of the swatch of land from the west coast in San Diego to the border of New Mexico/Texas along the international border with Mexico (and Texas has it covered for its own border, which is an interesting side note, indicating that Texas is actually considered its own sovereign jurisdiction, AKA Republic), and that the 90-day period ends on the 20th which is this upcoming Sunday.

That is all going very smooth, but there is a lag time in what is required to convert the credit to cash funds, and as a result of that lag and unexpected dip for these three payments, we are short \$1000 to cover the time between now and Monday. So if anyone can assist with that, please send what you can.

And as a reminder as I close this update, please keep in mind that what you will hear in my video about all the plans, is that it is not just about achieving stability for PTV and its baseline operations. It is also about building capacity to create the Master Plan regardless of what happens with MMLT, even if they never show up. And in order to do that it also requires that all of our members who have sacrificed a lot financially and otherwise, and all members in need of their own stabilization, are part of the plans.

Despite the sentiments expressed by a couple of less than supportive missives and diatribes by less than considerate individuals, we do in fact think of all of you every single day, and will not rest in thoughts or actions until we are all stable and beginning to prosper together. And what we have achieved in the last four to five months has accomplished that, although of course with a longer time trajectory compared to if/when LT shows up.

I will say, also, that the stress relief for us in the home front has been significant. Waking up every day to the ring tone of MM and the constant numbers now gone, that alone has enabled us to catch up and start really building real plans and actions. That has also enabled me, with the significant reduction of stress, to be able to put real time and energy into building requirements on the web sites, ES and SC documents for the Commonwealth countries, and other tasks that almost always got pushed aside due to the load and burden of stress and the continuous need to find money for MM and our baseline.

So once again I want to thank all of you and express my gratitude for what you have all done to contribute to make this all happen and to sustain PTV through some very challenging times. We all here at home base appreciate all of you very much for Being Here. And as Scoop always says: "Gratitude! That's the food to change your mood...so Give Thanks! "Cause that's the kind of wealth you don't find in the banks!"
